Pursuant to due call and notice thereof a regular meeting of the Common Council of the City of Bloomer was called to order on Wednesday, April 13th, 2022, at 5:15 p.m. at City Hall, 1503 Main Street – Mayor Koehler presiding.

Meinen made a motion to approve the minutes from the March 23rd, 2022, council meeting as presented. Baribeau seconded the motion. Motion carried.

Motion (Meinen/Reischel) to approve staffing the beach with lifeguards from June 11th to July 31st with the hours of 11 – 7.

Motion (Meinen/Baribeau) to accept the high bid of \$162 per acre from Tim Seibel for rental of land within the industrial park.

Motion (Meinen/Reischel) to approve Resolution #05-22 – Approving the Second Amendment to Vacant Land Offer to Purchase.

Motion (Baribeau/Reischel) to approve Ordinance #03-22 – Amending Special Requirements for Residential Driveways.
